Ad Formats

theSun accepts ad materials in digital format.

Ad Artwork Format

- Ad artwork format should only be in JPEG or Adobe Acrobat PDF formats with all fonts embedded. Artwork should be in CMYK mode.
- theSun accepts delivery of ads in digital format on CDs and via Asia On Time and EADS networks.

Image Resolution

- Images should be rendered at a resolution of 300 dpi at full size.
- Line copy should be prepared in black.

Cropping & Bleeds

- All artwork must be cropped to size.
- Do not include bleeds as theSun is a NON-bleed publication.

Payment Terms

- Approved Advertisers and/or their advertising agencies must make payment within 30 days from the invoice date, failing which interest on late payment calculated at 1.0% per month will be imposed.

Proof

- A proof of the ad material is required.
- It should be provided on newsprint.

COLOUR ADS

Font Type / Specs

- White text reversed out of four-colour background should not be less than 12-point size. A boldface type font is recommended. Thin strokes in type and lettering will result in misregistration of background colours.
- For fine wordings or small text in black, use only solid black (C=0, M=0, Y=0, K=100). Avoid using rich black / 4-colour black which will result in misregistration.

Proofs

- 2 sets of final colour proofs are required.
- These should be provided on newsprint.
